## **Westward House School**

## **About Westward House School**

Westward House is an independent special school located in St Clears, Carmarthenshire.

The school provides education for children and young people between the ages of seven to sixteen years who have specific learning difficulties including; dyslexia, dyspraxia, dysgraphia, dyscalculia, as well as learning difficulties associated with autistic spectrum condition (ASC), and attention deficit disorder. In addition, the school provides education for pupils who have no specific learning need but whose parents wish to enrol their child as an alternative to local state schools, for example as part-time provision where parents have elected to educate their child at home.

There are currently twelve pupils on roll. No pupils have statements of special educational needs, however, a minority are undergoing statutory assessment. No pupils are placed by a local authority.

The lead teacher has been in post since the school was established in February 2021 and is supported by a team of two teachers and two learning support assistants.

## **Main findings**

## Strengths

Over a relatively short period of time most pupils make noteworthy progress in all of their skills including literacy, numeracy and, social and communication skills. In addition most pupils attend the school regularly and clearly enjoy their time at school.

Staff have established positive and trusting relationships with pupils. They understand the needs of pupils well and are empathetic. They provide pupils with valuable support in lessons and throughout the day.

The school has developed appropriate assessments and tracks pupils' progress effectively.

The collaborative approach to planning the curriculum has engaged pupils well. As a result, pupils have increased ownership over what they learn and are developing very useful research and enquiry skills.

The school's restorative and reflective approach helps pupils to develop positive relationships with their peers and staff.

#### Recommended areas for action

Ensure that there is a regular cycle to review all school policies and that these align with the Independent School Standards [Wales] Regulations 2003.

Continue to adapt the curriculum, resources and opportunities for accreditation to meet the changing needs of pupils.
