About Ysgol Y Rhos

Ysgol y Rhos is located in the grounds of two former holiday lodges in a rural area between Wrexham and Mold.

The proprietor, Unique Care Homes Ltd., runs three children's homes in Wrexham and Denbighshire. The homes provide residential care and therapy for children aged 8 to 16 years with a history of trauma and adverse childhood experiences. Many of the children have a history of placement breakdowns and exclusion from mainstream schools. Currently, eight pupils are educated on-site. A further four pupils are educated in mainstream schools.

Many of the children are placed by local authorities in North Wales, including Gwynedd, Ynys Môn, Conwy and Denbighshire. A few children are placed by local authorities in England. A few pupils are from Welsh-speaking backgrounds and have previously attended Welsh-medium schools.

The current headteacher was appointed in April 2019.

Main findings

Strengths

The company has appointed suitably qualified and experienced staff who have created a warm, nurturing culture at the school. They have high expectations for pupils' progress, communicate enthusiasm for learning, are flexible in approach and responsive to pupils' needs.

Nearly all pupils engage purposefully in their learning. They respond well to the relaxed, supportive environment. Over time, they develop positive attitudes about themselves and others.

The curriculum is broad and balanced. The school makes effective use of the local environment to support the delivery of the curriculum. For example, staff use the extensive grounds creatively to teach about bush craft and to build shelters.

The strategic management of the school is effective. Development planning highlights appropriate priorities for improvement. This includes the need to improve interventions and the trialling of new resources to support pupils' literacy.

Recommended areas for action

Make sure that support staff is consistent and has suitable skills, training and expertise to meet pupils' learning needs.

Improve the provision for the delivery of information communication technology curriculum (ICT). Ensure resources enable pupils to develop their skills in ICT and to use their learning to support other areas of the curriculum.

Embed the use of data as a tool for recording, evaluating and planning for pupils' progress.

Review procedures to involve the headteacher in planning for the admission of new pupils so that appropriate measures are in place to ensure the smooth transition in and induction of new pupils to the school.
