About Oakmont School

Oakmont School is an independent day school located in a large, detached building, close to a retail park near Cardiff Bay in a suburban area of Cardiff. The school is part of the portfolio of Oakmont Services Group and a subsidiary of Audere Holdings Limited which are both private limited companies.

The school is registered for 16 pupils, aged 11 to 16 years old, who are facing challenges relating to social, emotional and mental health difficulties. Currently there are five pupils on the school roll aged between 11 and 14 years. All pupils are placed by local authorities in Wales and have an individual development plan (IDP) or statement of special educational need (SEN).

The headteacher has been in post since the school was established in September 2023. They are supported by the Director of Education for Oakmont Services. The school also has two qualified class teachers and four teaching assistants.

Main findings

Strengths

Leaders have a clear vision for the school and are in the early stages of establishing a curriculum that appropriately matches this vision of 'learn, grow, lead'.

Staff are thoughtful in their approach and are in the process of building positive and trusting relationships with pupils. They are beginning to understand the needs of pupils well. They provide pupils with valuable support throughout the day and act as positive role models.

Nearly all pupils attend school very well. This represents strong progress from previous education placements.

The strategic management of the school is sound. Leaders have highlighted appropriate priorities for improvement within their school development plan. This includes the need to widen the staff skillset and the use of new resources to support pupils' literacy, numeracy, and well-being. In addition, appropriate resources have been identified to support staff with tracking and monitoring pupils' progress in a range of areas.

The new school site is bright and welcoming, and the proprietor has made significant investment in ensuring that the building is fit for purpose.

Recommended areas for action

Ensure that the proprietor pays appropriate regard to the registration and operational guidance for independent schools in Wales.

Continue to adapt the curriculum, resources, and opportunities for accreditation to meet the needs of pupils as the school cohort continues to grow.

Develop community partnerships to allow pupils to widen their learning experiences, particularly in aspects of spiritual, moral, social, and cultural education.

Continue to develop professional learning opportunities for staff to develop further their skills to support pupils with complex additional learning needs.
